#### INSTRUCTIONS FOR AUTHORS

Journal of Medical Research is a scientific journal of Hanoi Medical University, published 6 regular issues per year in Vietnamese and at least two issues in English. We publish manuscripts based on original research, narrative and systematic review and case reports in the field of biomedical sciences, clinical medicine and nursing, preventive medicine and public health.

#### I. SUBMISSION GUIDELINES

The manuscript must be written in standard Vietnamese or English, using Arial font and size 13 pt (Unicode font system) and lines spaced at 1.5. The maximum length is 4,000 words (about 10 pages) including tables, figures and references. The pages should be numbered.

The manuscript should be composed using Microsoft Word. The tables, graphs which are presented in other formats (.jpeg, .pdf, etc.) must be included within the main manuscript and submitted together with original files to the editorial board.

In the title page, contact details of corresponding author should be presented.

#### II. ETHICAL CONSIDERATIONS

The Journal of Medical Research will review manuscripts following guidelines by the International Committee of Medical Journal Editors (ICMJE). Authors should clearly state if they have any conflict of interest and acknowledge their sources of funding (form 1 in the submission guideline). The authors take responsibilities towards the editorial board, the public and the relevant provisions of Vietnam for their manuscript's contents.

#### III. REVIEWING PROCESS

Since 2014, the journal started to implement an online management system using Open Journal Systems (OJS). Authors are encouraged to submit papers online using the following link: <a href="http://tapchinghiencuuyhoc.vn/index.php/yhonline/login">http://tapchinghiencuuyhoc.vn/index.php/yhonline/login</a>. Each manuscript will be anonymously assessed by 02 reviewers who have expertise in the fields related to the manuscript.

#### V. REQUIREMENTS FOR SPECIFIC TYPES OF MANUSCRIPT

#### 1. Review Article

#### **ARTICLE TITLE**

(Brief, concise and avoid abbreviation)

**Author<sup>A</sup>, Author<sup>B</sup>, Author<sup>C</sup>** (Ordered by levels of contribution) Organization<sup>Y</sup>, Organization<sup>X</sup>, Organization<sup>Z</sup>

Summary: Briefly outine the topic, purposes of the paper and data collection, data analysis, references, research implications and conclusion. The summary is written in one paragraph with no more than 200 words.

Key words: Present the main topic of the research, the maximum number of words/phrases is 6.

#### **BACKGROUND**

State the review issue and its rationale; the significance of the review topic; views and approachs of authors when review the issues.

#### I. REVIEW CONTENT

Can be divided into subsections according to the views and approaches of the author and should point out the trend of future studies regarding the review topic. Authors should prioritize published documents close to the time when carrying out the article review.

#### II. CONCLUSION

Clearly state the information provided from the review article, whether it meets the purpose of the review article and outline implications for future studies.

#### **Acknowledgements**

Authors express the gratitute towards individuals and organizations who supported and helped carry out the review article.

#### **REFERENCES**

Follow the manuscripts presentation guidelines, no restrictions on the number of references in the review article.

#### Summary

#### 2. Original Research Paper

#### **ARTICLE TITLE**

(Brief, concise and reflective of the topic,
Avoid phrases start with: investigate, examine, evaluate and avoid abbreviation)

Author<sup>A</sup>, Author<sup>B</sup>, Author<sup>C</sup> (Contribution raged from more to less)

Organization<sup>Y</sup>, Organization<sup>X</sup>, Organization<sup>Z</sup>

Summary: Present main results of the study. The summary is written in one paragraph with no more than 200 words.

Key words: Present the main topic of the research, the maximum number of words/ phrases is 6

#### I. BACKGROUND

Introduce the purposes of the research in the relation to previous studies. The lenghth of the paragraph is one page (approximately 500 words). It should include at least 8 references.

#### **II. SUBJECTS AND METHODS**

Briefly and concisely describe the research protocol and implementation. For new procedure, it should be described in detail, cite references for this study procedure. State the Institutional Review Board (IRB) which approved the implementation of this study.

#### III. RESULTS

Figures, tables are presented clearly with brief captions. Some results, not presented by tables, can be described in paragraphs. The total number of tables and figures is no more than 5. Photos are scanned into the right position and must have an accompanying original photo.

#### **IV. DISCUSSION**

No more than 2 pages, only discuss and explain issues related to the results.

#### V. CONCLUSION

Brief, should not list all results from the study.

#### **Acknowledgements**

Authors clearly state funding agencies (if any) and state if any conflict of interest exists. This section is presented prior to references and no numbering.

#### **REFERENCES**

References are cited by number, not by author and year. Documents are collected and arranged in the citating order within the article. Documents in foreign languages must be kept verbatim, without transliteration and translation. Each article should cite no more than 15 references, except for the review articles. A reference is presented as following: full name of the author (if the author is a foreigner, the order is: full last name, acronym middle name and first name), year of publication, article title, journal name (in italics), nature (number) (in bold), p. If the article has many authors, only write the name of the first 03 authors and co-authors, for example:

Introduce the social and historical context of the case study, help readers understand the benefits of reading the disease's information.

#### II. CASE STUDY INTRODUCTION

Describe the context of case discovery, plans, the process of management and treatment, outcomes.

#### III. DISCUSSION

No more than 2 pages, outline the explanations about the circumstances of pathogenicity and results.

#### **IV. CONCLUSION**

Briefly and should not list all results from the study.

#### Acknowledgements

Authors express the gratitute towards individuals and organizations who supported and helped carry out the research.

#### **REFERENCES**

Follow the instructions of research publication manuscripts.
